

# **SISTIC X CIRCLES.LIFE** Circles.Life Application Terms & Conditions (SISTIC bookings)

# 1. Relationship between SISTIC and us

1.1 We operate the Circles.Life mobile application ("Application"). SISTIC provides ticketing services and is a provider for various events in Singapore ("Services"). We have partnered with SISTIC to allow users of the Application to make SISTIC bookings directly through the Application.

1.2 SISTIC, and not us, is the offeror of the Services. We merely facilitate payment between SISTIC and you for SISTIC bookings made through the Application. For refund related issues or other complaints, please contact SISTIC directly for assistance.

1.3 For payment, cancellation, refund, show relocation, show postponement issues and credit card disputes, you may contact our customer service and we will assist you accordingly.

# 2. Bookings and Confirmation of Bookings

2.1 Your SISTIC booking is only completed after you have made payment and received a confirmation email from us, which subject to the policies of SISTIC, may include an e-ticket or printable version of your ticket ("Ticket").

2.2 We reserve the right to accept, reject, and/or amend any orders made by you for SISTIC bookings. We further reserve the right to, in our sole discretion, cancel your bookings if you are in violation of these terms and conditions.

# 3. Terms and conditions governing the Tickets

# <u>Usage</u>

3.1 You shall adhere to <u>SISTIC's terms</u> governing the use of your Tickets ("SISTIC T&C"). We will not be responsible for any consequences as a result of your failure to adhere to the SISTIC T&Cs

# Cancellation and refund of Tickets, Postponement or Cancellation of events

3.2 Terms relating to the cancellation and refund of Tickets, postponement or cancellation of events argoverned by the SISTIC T&Cs.

3.3 We will direct all requests for refunds to SISTIC. We may process refunds, but only on behalf of SISTIC and as may be authorised by SISTIC. In the event that SISTIC does not authorise such refunds, we will not be held liable and be under no obligation to process any refunds at all.



#### **4.Additional Charges**

4.1 We may require you to pay additional fees or charges in connection with your SISTIC booking through the Application. Such fees will be made known to you prior to payment.

4.2 We reserve the right to change such additional fees or charges from time to time.
